In pursuance of the provisions contained in the GOs cited, the following police personnel, who have completed 22 years of eligible service including basic training period, are designated as ASI (Grade), strictly as per the conditions detailed in the PHQ circular cited.

ASI Grade

The person so designated will be eligible to wear the uniform of Assistant Sub-Inspector. He will not be eligible for higher pay and allowance other than what he would have received had he not been designated as Assistant Sub-Inspector. He will be accommodated among the available sanctioned post in the rank of Head Constable. He will be entrusted with the duties and responsibilities of a regular Assistant Sub-Inspector additionally, in such a manner and to such an extent as the Director General of Police may deem appropriate. He will not be eligible to claim seniority in the cadre of Assistant Sub-Inspector on the basis of his designation.
