In pursuance of the provisions contained in the references cited, the following police personnel of Kochi City who have completed 15 years of service including training period (vide Ref. 6) are designated as Sr. CPO (Grade) strictly as per the following conditions.

Sr. CPO Grade

The personnel so designated are eligible to wear the uniform of Head Constable. They are not eligible for higher pay and allowance other than what they would have received if they have not been designated as Head Constable. They will be accommodated among the available sanctioned post in the rank of Constable. They will be entrusted with the duties and responsibilities of a regular Sr CPO additionally, in such a manner and to such an extent as the Director General of Police may deem appropriate. They are not eligible to claim seniority in the cadre of Head Constable on the basis of their designation.
